I hereby contact you because I think the safety of people in multiple European countries is seriously endangered, and because of this I hereby provide you with copies of documents regarding the investigation of the Prosecutorial Office of the Republic of Bulgaria, which has continued for three years and has ended on 02.07.2013, on signals I have submitted against a minister, deputy-minister, director and deputy director of an agency, for a suspicion in organizing and cover-up of corruption practice in the issuance of driving licenses to almost illiterate candidates for drivers of motor transportation vehicles, mostly members of Roma minorities and citizens of third countries, residents in countries of the European Union. On the signals I have submitted for corruption in the high-ranks of

government, Sofia City Prosecutorial Office, Sofia Prosecutorial Office of Appeals and the Supreme Prosecutorial Office of Cessation has issued ten prosecutorial orders, but evident from the documents I hereby provide you with, the corruption practice has not only been terminated, but also it has turned into "a profitable business", and if no urgent measures are taken, many people will be injured and killed on the roads of the Republic of Bulgaria, as well as the roads of the Federal Republic of Germany, Republic of France, the Kingdom of Great Britain, the Kingdom of Netherlands, the Kingdom of Belgium, and many other European countries. Because of this reason, I hereby contact you and ask help, with the single appeal: to order an inspection on the documents provided by me regarding the above-specified investigation of the Prosecutorial Office of the Republic of Bulgaria, and if possible send an invitation to me, for hearing in the European Parliament, thus assuredly protecting the life and health of many innocent people, **including children.**
